- 2. Center of Excellence Updates ASQ Training 44 participant feedback was good
- -This fall's focus Inspire Action Program improvement plan Maura did last year as part of piloting. Evidence based practices looking internally at what needs to be done to improve not a requirement but look to see if they need a plan. St Cloud is doing it now
- -ECTA Early Childhood Technical Assistance when children are in early childhood programs they are really engaged Cindy and her staff have been through training and will be mentoring other teachers
- 3. MOFAS Early Childhood Screening Project SueTerewy Early Childhood Screening Project Manager

- -Average age was 8-12 for diagnosis and we know they need to be identified earlier.
- -How can we help providers diagnosis earlier?
- -See handouts
- -MOFAS does training
- -Health Care Providers are still saying a "glass of wine" is fine now and then and it's not
- -If release is signed to send to school right away at clinic that testing has been done, then they can receive services right away.
- -Reframe away from parent having done something wrong to doing something right for your child
- -May be changing legislatively to include substance use not only in mother's file but also in child's file
- -MOFAS wants to do more sooner what they are doing to help see Screening for PAE handout
- -Trainings are anywhere from 1.5 -3.5 hours What is FASD and How do you ask the tough questions can do a full day 6 hours
